5. WINDOWS AND DOORS SHALL BE CLOSED DURING LIVE ENTERTAINMENT PERFORMANCES AND COMPLIANCE WITH THE CITY OF NEW ORLEANS NOISE ORDINANCE IS REQUIRED. IN THE VIEUX CARRE DISTRICTS, MUSIC OF ANY KIND IS PROHIBITED OUTSIDE THE BUILDING UNLESS AUTHORIZED THROUGH THE CONDITIONAL USE PROCESS.

REPLACEMENT APPLY ONLY IN VIEUX CARRE DISTRICTS (PERMITS SPEAKERS IN COURT YARDS IN VC UNTIL 2:00 A. M.)

5. IN THE VIEUX CARRE DISTRICTS, RECORDED MUSIC OF ANY KIND IS PROHIBITED OUTSIDE THE BUILDING BUT NOT INCLUDING COURTYARD, UNLESS AUTHORIZED THROUGH THE CONDITIONAL USE PROCESS. RECORDED MUSIC IN COURTYARD SHALL NOT EXTEND BEYOND 2:00 A.M.
